1. To Note Members Present and to receive and approve apologies for absence

2. To receive any declarations of interest regarding the agenda

4. To agree and sign the minutes of the Town Council meeting of 6th July 2022 It was RESOLVED by all to agree the minutes and they were duly signed.

5. To receive reports from the following:

- c. Patients Participation Group at Rosedale Surgery Report distributed. Blood spinner been purchased by raising money from a Member of the public selling plants.
- d. IMPACT Detached Youth Ian popped in and had sent in reports.

- e. East Anglia Transport Museum Very busy summer. Tram arrived from Blackpool in July. Starting work on new buildings next week. Heritage weekend 10th/11th September. Request for bus for next year 4th June 2023.
- f. Allotments All fine new water connection excellent at Borrow Close. School continuing open day in August went well. Jubilee Bench is doing really well.
- g. Carlton Colville Community Centre No meeting in August
- h. Carlton Colville Community Kitchen and Wildlife Garden Tap had been vandalised but now been mended. Children's Activities on Tuesday mornings had mixed attendance. A plan of events for next year to be drawn up. Wildlife pond in. Resource to be used by local schools.

6. Public participation

The purpose of the meeting is for Councillors to discuss Town Council Business. During each meeting the Council will allow a period of up to 15 minutes for public questions. During this time, residents can put questions to the Chairman regarding local concerns. Each question will be allocated 3 minutes. Where possible the Chairman will respond but matters may have to be deferred and placed on a later month's agenda for discussion. No questions were raised

7. To consider the next steps for Historic minutes dating to the 1800's handed to the Town Clerk

Julie Hall has begun to transcribe it. It was agreed to look into the ossibility of displaying it at local museum Everitts Park.

8. To update on potential Street Art project at Carlton Meadow Park

Initial meeting had taken place with East Suffolk Council. Community officer Gemma Fraser Had been in touch with Ash from ABC Skateboarding and he's really happy to be involved. She has found two other potential street artists as well as Knapple who had been used in other projects locally. Potentially a further aspect to the project for consideration by the group is working with Mike Chaplin from Suffolk Positive Futures/Catch 22 to run a weekly sports coaching session somewhere in the area (Community Partnership funding from 21/22). The aim is to offer a programme for young people that improves mental health, increases access to sport, tackles isolation and anti-social behaviour. If we can get the data showing the need he can offer weekly sports sessions at Carlton Meadow Park from April to October next year. Meeting on site with all parties to discuss to be arranged.

9. To agree payments for July & August 2022

10. To confirm that the Town Council will be continuing with the External Audit arrangements and not opting out of the current scheme.

It was RESOVLED by all to continue with the existing External Audit arrangements.

It was RESOLVED by all to purchase a Dog bin at Carlton Meadow Park also Ashtree Gardens green space. Bloodmoor Bridge junction with Ridgeville and halfway up Bloodmoor Road

12. To discuss initial plans for Fete next year

It had been decided that Sunday 4th June 2023 would be the event 11 am until 4 pm. 'Carlton Colville Fest' (Festival). Community groups such as Scouts and Church to be invited again. All emergency services to be requested again. More food and drink stalls and children's activities to be sourced. Bands/choirs to be looked into. Allotments to think about growing produce to show.

It had been noted that 30 mph speeding signs be requested on the Dales Estate – response from SCC - As with all town or village streets which have regularly spaced street lighting along them, the Highway Code states that the speed is 30 mph unless otherwise displayed, so the need to be constantly reminded that it is 30mph is deemed unnecessary. It is only where the speed changes to another level that a sign would be installed e.g. 20mph zone Anchor Way/Beccles Road cycle path and main road need clearing/trimming back Chapel Road footpath to the Oaks needs clearing
